## **Project Details:**

The Section 8 design-build project consists of designing and building 2.63 miles of limited access toll road from Orange Boulevard to east of Rinehart Road. The project includes a Wekiva Parkway interchange connecting to Interstate 4 (I-4) and State Road (S.R.) 417, completing the beltway around Central Florida. Work will include the design of bridges, drainage, lighting, sign and pavement markings, utilities and other roadway features.
