U.S. 17-92 Improvements, Orange County

The Florida Department of Transportation (FDOT) will hold a public hearing regarding project plans on U.S. 17-92 on Thursday, April 29, at 5:30 p.m. The purpose of this project is to provide pedestrian and traffic improvements along U.S. 17-92 from south of Nottingham Street to Monroe Avenue that enhance mobility and safety. FDOT is offering multiple ways to participate in the same live hearing.

Virtual: Join from a computer, tablet, or mobile device for free and listen to the live presentation over the internet. Advance registration at tinyurl.com/1792Register is required; participants will receive an email with information about joining the hearing online. Please note, Internet Explorer cannot be used to register or attend this webinar.

Phone (Listen Only): Join the hearing in listen-only mode by dialing 1-877-568-4108 and entering the passcode 227-486-091 when prompted. Callers may submit comments directly to the project manager by using the contact information listed below.

All safety and sanitation guidelines and local ordinances must be followed. Persons who are not feeling well should not attend the in-person hearing.

The hearing will open at 5:30 p.m., and the presentation will begin promptly at 6 p.m. If joining online, please allow adequate log-in time prior to the presentation.
